1 Lus qhia txog koj tus menyuam

Ntawm no koj yuav pom koj tus menyuam tus naj npawb kawm ntawv, hnuv yug, qib kawm, nyob qib theem CAPA dab tsi, hnuv xeeem, lub tsev kawm ntawv, thiab cheeb tsam. Yog hais tias muaj, kuj yuav pom koj qhov chaw nyob rau hauv seem no thiab.

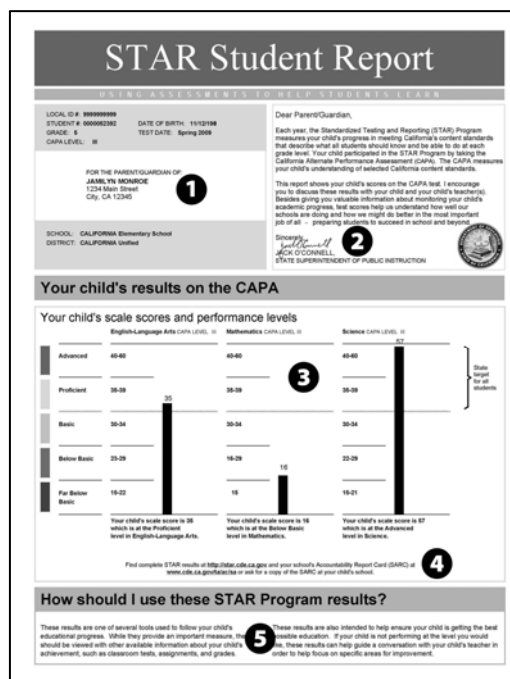
2 Tsab Ntawv Nthuav Lus los ntawm Xeev Tus Thawj Saib Xyuas Txog Kev Kawm Ntawv Dawb Rau Pej Xeeem

Hawm txog Niam Txiv/Tus Saib Xyuas, Txhua xyoo, California Cov Qauv Xeeem Ntawv thiab Qhia Txog Qhov Kev Xeeem Ntawv (California’s Standardized Testing and Reporting (STAR) Program) mas ntsuas seb koj tus menyuam puas xeeem dhau California Cov Qauv Paub Ntawv (California Content Standards) uas qhia txog seb txhua tus menyuam kawm ntawv yuav tsum tau paub thiab ua tau dab tsi hauv ib qib kawm twg. Koj tus menyuam tau koom tes nrog rau hauv qhov Kev Pab Cuam STAR los ntawm qhov kev xeeem California Lwm Txoj Kev Soj Ntsuam Txog Kev Paub Ntawv (California Alternate Performance Assessment [CAPA]). Daim ntawv xeeem CAPA mas ntsuas txog koj tus menyuam txoj kev txawj hauv California tej co qauv paub ntawv uas xauv.

Daim ntawv qhia no qhia txog koj tus menyuam cov qhab nees uas nws tau thaum xeeem cov kev xeeem hauv CAPA. Kuv txhawb kom koj nrog koj tus menyuam thiab koj tus menyuam tus kws qhia ntawv tham txog cov qhab nees no. Dua li ntawm qhov uas muab cov lus qhia tseem ceeb txog koj tus menyuam qhov kev kawm ntawv tau zoo thiab tsis tau zoo, cov qhab nees tseem pab kom pab kom kom siab txog seb peb cov tsev kawm ntawv ua tau zoo npaum li cas thiab seb peb yuav ua kom zoo tshaj ntxiv li cas hauv qhov tseem ceeb tshaj ntawm peb txoj hauj lwm – uas yog npaj cov menyuam kawm ntawv kom muaj kev vam meej hauv tsev kawm ntawv thiab dhau tov.

3 Koj tus menyuam qhov ua tau zoo thiab tsis zoo hauv daim CAPA

Saib cov kab ua tej ya dub dub uas khiav ntsug hauv qab ntawm ib qho kev kawm twg uas yuav qhia rau koj seb koj tus menyuam xeeem tau siab npaum li cas hauv CAPA. Tus lej uas sau rau saum toj ntawm cov kab yog koj tus menyuam qhov qhab nees tau hauv qhov kev xeeem hauv qhov kev kawm ntawd. Cov thawv uas muaj kob nyob rau sab laug thiab cov ntawv hauv qab ntawm txhua txoj kab mas qhia txog seb koj tus menyuam xeeem tau zoo npaum li cas hauv txhua qhov kev kawm: Lus Asnkiv thiab leb rau tag nrho cov menyuam thiab xais-yees rau cov menyuam kawm ntawv qib tsib, yim, thiab kaum. Muaj tsib qib: qib siab (advanced), qib paub txaus (proficient), qib paub (basic), qib tsis paub zoo (below basic), thiab qib poob qis (far below basic). Lub hom phiaj hauv California mas yog kom tag nrho cov me nyuam kawm ntawv ua tau kom txog rau qib paub txaus los sis qib siab. Cov qib theem hauv CAPA mas nws tsis zoo ib yam li cov qib theem hauv lwm cov kev xeeem hauv Qhov Kev Pab Cuam STAR.



4 Koj yuav nrhiav tau Qhov Kev Pab Cuam STAR cov qhab nees nyob rau hauv California Department of Education (CDE) STAR Cov Qhab Nees lub Web page ntawm <http://star.cde.ca.gov/> thiab koj lub tsev kawm ntawv tsab ntawv pov thawj qhia txog tsev kawm ntawv (accountability report card) txog CDE Tsab Ntawv Pov Thawj Qhia Txog Tsev Kawm Ntawv (School Accountability Report Card (SARC) hauv lub Web page ntawm <http://www.cde.ca.gov/ta/ac/sa/>. Koj tseem mus thov tau ib daim qauv SARC tom koj tus menyuum lub tsev kawm ntawv los tau thiab.

5 **Kuv yuav siv Qhov Kev Pab Cuam STAR cov qhab nees li cas?**

Seem no muab tswv yim txog cov kev los saib xyuas koj tus menyuum txoj kev kawm ntawv, los ntawm cov xeem hauv chav kawm, cov ntawv nqa los ua tom tsev, thiab cov qhab nees. Koj siv tau cov tswv yim no mus nrog koj tus menyuum tus kws qhia ntawv tham txog kev yuav ua li cas thiaj li pab tau koj tus menyuum kom kawm ntawv tau zoo ntxiv.

6 **Lus qhia txog CAPA**

Seem no muaj cov lus qhia ntxiv hais txog CAPA thiab seb siv li cas. Nws qhia txog cov qib theem hauv CAPA thiab cov kev kawm uas yuav xeem thiab muab ib qho uas txuas mus rau cov qauv uas cov menyuum yuav raug xeem los ntawm CAPA.

Feem ntau cov menyuum uas muaj feem xeem tus CAPA yeej xeem qib uas thwj rau nws qib kawm tom tsev kawm ntawv, tiam sis ib co menyuum kawm ntawv uas muaj kev xiam oob qhab yuav raug xeem Qib Ib xwb. Cov qib xeem nws tsis thooj li tus menyuum txoj kev txawj hauv tej qib kawm twg. Cov ntawv xeem Lus Asnkiv, lej, thiab xais-yees mas yeej yog cov nyob ua ke koom ib qib xwb.

7 **Lus qhia ntxiv txog Qhov Kev Pab Cuam STAR**

Seem no qhia dav dav txog qhov kev pab cuam STAR thiab muab qhov chaw nyob hauv Web rau CDE Qhov Kev Pab Cuam STAR lub Web page.

Thaum uas koj tus menyuum yuav txawj ua li cov kev siv hauv daim ntawv xeem, qhov qhia tias txawj txog siab li cas mas yog raws seb koj tus menyuum xeem tau qhab nees li cas hauv qhov kev xeem ntawd xwb. Nrog koj tus menyuum tus kws qhia ntawv tham kom paub meej dua ntxiv txog koj tus menyuum cov kev kawm thiab kev txawj.

About the CAPA **6** JAMILYN MONROE

The California Alternate Performance Assessment (CAPA) is a standards-based test for students with significant cognitive disabilities who are unable to take California standards tests even with accommodations or modifications. Your child's individualized education program (IEP) team decided that the CAPA was appropriate for your child.

The CAPA is administered one-on-one; that is, an examiner, usually the child's teacher, administered the CAPA to each child individually. The CAPA is a performance test; the examiner set up objects or pictures and asked the child to do or say something related to the objects. The examiner then recorded the child's score based on the child's response.

The CAPA is organized into five assessment levels. Most children eligible for the CAPA take the assessment that corresponds with their current school grade. The levels are as follows:

Level I, grades 2 - 11 (Note: Eligibility for Level I is determined by the child's IEP team. Children who take CAPA Level I are receiving curriculum and instruction aligned to Level I blueprints.)

Level II, grades 2 - 3
Level III, grades 4 - 5
Level IV, grades 6 - 8
Level V, grades 9 - 11

English-language arts and mathematics are administered at all CAPA levels. Science is administered to children taking the test for levels I, III, IV, and V. Each subject has twelve tasks for the child to perform. The assigned level is not related to individual ability in a particular subject. Your child was tested on all subjects at the same level.
