1 Lus qhia txog koj tus menyuam

Txhua xyoo, California Cov Qauv Xeeem Ntawv thiab Qhia Txog Qhov Kev Xeeem Ntawv (California’s Standardized Testing and Reporting (STAR) Program) ntsuas seb koj tus menyuam puas xeeem dhau California cov qauv paub ntawv hauv chav kawm thoob hauv ntiaj teb. Cov qauv no qhia txog seb txhua tus menyuam kawm ntawv yuav tsum tau paub thiab ua tau dab tsi hauv ib qib kawm twg. Koj tus me nyuam koom rau hauv Qhov Kev Pab Cuam STAR los ntawm kev xeeem tus California Kev Xeeem Uas Tau Kho Lawm (California Modified Assessment) (CMA). Tus CMA ntsuas koj tus me nyuam txoj kev nkag siab rau qee yam hauv California cov qauv paub ntawv.

Daim ntawv qhia no qhia txog seb koj tus me nyuam xeeem tau li cas rau hauv daim CMA. Kuv txhawb kom koj nrog koj tus menyuam thiab koj tus menyuam tus kws qhia ntawv tham txog cov qhab nees no. Qhov uas paub los ntawm kev xeeem CMA yuav pab tau kom peb nkag siab txog seb peb cov tsev kawm ntawv nws ua tau zoo li cas thiab seb peb yuav ua li cas kom zoo ntixiv hauv txoj hauj lwj uas tseem ceeb tshaj plaws – npaj kom cov me nyuam kawm ntawv muaj kev vam meej hauv tsev kawm ntawv thiab dhau ntawd tov.

3 Koj tus menyuam qhov ua tau zoo thiab tsis zoo hauv daim CMA

Tau xeeem koj tus me nyuam hauv lus asnkiv (English–language arts), lej, thiab/los sis xais-yees (science) (qib kawm tsib thiab yim). Tsuas qhia cov qhab nees rau hauv qhov kev kawm uas xeeem hauv CMA cov kev xeeem uas koj tus me nyuam xeeem xwb. Yog koj tus me nyuam tsis xeeem ib los sis ntau tshaj ib qho kev xeeem los sis yog hais tias tsis qhia qhab nias, muaj sau txog qhov no nyob rau hauv daim ntawv qhia seb koj tus menyuam xeeem tau li cas.

Koj tus menyuam rab teev luj seb nws tau qhab nias pes tsawg thiab seb nws ua tau zoo txog qib theem twg—Saib seb koj tus menyuam xeeem tus CMA tau siab npaum li cas uas saib cov kab ua tej ya dub dub uas khiav ntsug hauv qab ntawm ib qho kev kawm twg. Yog hais tias koj tus menyuam nyob hauv qib kawm peb, plaub, los sis tsib, tus zauv nyob rau sab saum toj ntawm txhua txoj kab ua tej ya yog koj tus menyuam tus qhab nias xeeem tau rau hauv qhov kev kawm ntawd. Cov thawv uas xim nyob rau sab laug thiab cov lus nyob rau hauv qab ntawm txhua txoj kab ua tej ya dub dub qhia txog koj tus menyuam txoj kev ua tau zoo li cas hauv txhua qhov kev kawm uas xeeem ntawd. Muaj tsib qib ntawm txoj kev ua tau zoo: qib siab (advanced), qib paub txaus (proficient), qib paub (basic), qib tsis paub zoo (below basic), thiab qib poob qis (far below basic). About the CMA 6
The California Department of Education (CDE) has developed and in California Modified Assessment (CMA). The CMA is a standards-based test for students with disabilities. Your child's individualized education program (IEP) team decided the child in one or more subject areas.

A student's IEP team, which includes parent/guardian input, determines participation in the CMA by considering the following California State Board adopted CMA participation criteria:

- Previous participation in the California Standards Tests (CSTs) or the California Performance Assessment (CAPA).
- Progress based on multiple measures and objective evidence;
- Response to appropriate grade-level instruction;
- The student is not precluded from attempting to complete requirements, as defined by the State, for a regular high school diploma; and
- Parent/guardians are informed that their child's achievement will be measured based on modified achievement standards.

The CMA has been developed so students can better demonstrate their knowledge of the California academic content standards. Some ways the CMA has been made more accessible to students with disabilities compared to the CSTs include:

- Fewer answer choices per question
- Shortened passage length
- Larger font size and use of a font type that is easier to read for most students with visual disabilities
- One-column format for most test questions
- Use of a calculator on the mathematics tests (grades 5 through 7 only) and science tests (grades 5 and 8) as an accommodation
